1. APOLOGIES

4. CHAIRMAN'S ANNOUNCEMENTS

- Notification has been received that part of Stirling Way is to be closed from Monday March 30th to Thursday 2nd April for remedial works. Clarification on the re-routing of the buses is being sought.
- A meeting has been held with Pam Hume regarding the placement of a commemorative bench on Crow Hill for Roger Hume. A request has also

been received from members of the community for a tree to be planted in the Burial Ground with a commemorative plaque. The Parish Clerk reported that a hedge and trees will need to be planted to screen the school and along the High Street so a plaque could be placed at the base of one of these.
