Dear Parish Clerk

I am writing to ask if Cambourne Parish Council would consider supporting Magpas – the award winning medical charity which provides emergency, life-saving care to critically ill and injured people in Cambridgeshire.

As you may know, Magpas was established more than 40 years ago and, today, responds to emergency accidents and incidents by both land vehicle and Air Ambulance. We utilise the talents of 50 Doctors and Paramedics – known as the Magpas Helimedix – to provide on-the-spot medical care for some of the most serious incidents in the region, such as road traffic accidents and cardiac arrests. Our research shows that patients who receive enhanced care from Magpas are around 20% more likely to survive their major trauma injuries. The Magpas Helimedix really are saving lives.

Injury is a major public health problem and, in the UK, the commonest cause of death for people under the age of 44. Every trauma death costs the nation in excess of £0.75 million and every major injury costs £50,000. By responding rapidly and providing the highest quality clinical care at the scene, Magpas can treat and stabilise an individual before they are transported to hospital. This gives them the very best chance of survival and improves both their recovery rate and their future quality of life. As Professor Sir Bruce Keogh, Medical Director for NHS England said: 'getting the right patient to the right hospital at the right time can save lives and improve recovery from serious trauma'.


In 2014, the Magpas Helimedix were dispatched to 874 incidents in nine counties across the East of England, including 337 in Cambridgeshire. On average, the team is dispatched to between one and two incidents each day – that's one or two lives potentially saved.



However, as demand for our service grows, so does our need to raise voluntary income. Magpas receives no direct government funding and so we rely on the generosity of individuals, organisations and Councils to support our work. For this reason, we truly hope you will be able to support Magpas by making a grant from your locality or personal budget in 2015.

Apologies for absence were received from Councillors Mark Howell, Mick Martin and Tim Wotherspoon.

1. INTRODUCTION

Councillor Ray Manning welcomed the parish councillors and other representatives to the meeting and introductions were made.

2. CITY DEAL

Councillor Ray Manning explained that the District Council, Cambridge City Council and Cambridgeshire County Council were working in partnership through the "City Deal" to secure £500 million from the Government for infrastructure improvements. The first £100 million will be received from the Government in April. Cambridge University has also become a partner in the City Deal along with the business sector.

Whilst acknowledging that even £500 million would not be enough to resolve all the infrastructure improvements the two districts required, Ray Manning explained that major improvements would be made and that it would have been wrong for the three authorities to turn down the funding. He added that the Council's preference was to have borrowed the funds from the Government, to be paid back in extra tax receipts. It has been calculated that for each £1 invested by the Government in the City Deal, a profit of £10 will be received in tax receipts.

Combined authority

A change in legislation will be needed to set up a combined authority, made up of representatives of all three authorities. It was noted that this was not a step towards the formation of a Unitary Authority.

Political consensus

Ray Manning responded to concerns that a change of Government in May could affect these arrangements, by explaining that there was a consensus amongst all three major parties to support City Deals.

Priority improvements

It was noted that improvements in infrastructure in South Cambridgeshire and Cambridge City would also benefit the rest of Cambridgeshire. The priority was to improve:

- The A428 west of Cambourne.
- The A1307 to the edge of the District.
- Park & Ride sites and other bus services.

Affordable homes

It was noted that whilst it would be challenging to build the 1,000 additional affordable houses required in the terms of the City Deal, the authorities had 15 years to achieve this target. It was understood that the Council was looking at building on public sector owned land and rural exception sites and not just relying on mixed sites with some market housing.

3. LOCAL PLAN: NEXT STEPS

In response to questioning, Councillor Robert Turner stated that he was aware of the strength of feeling against new development in the District and he explained that the Local Plan was being examined by the Planning Inspector. It was hoped it would be adopted by the end of the year. In the meantime the Council had to process all speculative planning applications with due diligence. It was noted that, as with the Waterbeach application, developers could gain planning permission on appeal, despite it being rejected by the Planning Committee.

The District Council will inform the parish councils of the Planning Inspector's next public hearing dates as soon as they become known.

A10

It was noted that improvements to the A10 were conditional on the development on the barracks site in the parish of Waterbeach. It was hoped that the new railway station at Chesterton could help relieve congestion. Robert Turner suggested that parish councils lobby their MPs to try and get road improvements agreed.

Northstowe

Robert Turner explained that the Northstowe Joint Development Control Committee was meeting on Wednesday 25 March to discuss Phase 2.

4. LOCALITY WORKING

Mike Hill, Director of Health and Environmental Services, explained that the Council aimed to improve communication by providing each parish council with a designated officer to be contacted first in all general enquiries with the local authority. Obviously parish councils could continue to call specific officers if they knew who to contact.

The aim was to introduce this from June and parish councils were invited to give feedback on this initiative. In response to questioning it was hoped that the scheme could be introduced earlier than June, although issues regarding the election could make this difficult.

5. ARTICLE 4 - CONSULTATION

Councillor Nick Wright explained that the Council recently consulted on Article 4 legislation, which would require a pub owner to gain permission from the Council before changing its use. 256 responses (16 from parish councils) had been received to the Council's consultation exercise and the results were being analysed. Currently only 16 pubs were listed as community assets and parish councils were encouraged to consider adding to the list.

It was noted that there could be good commercial reasons for changing a pub's use, especially if there were other pubs in the village. It was also understood that companies which owned pub chains were struggling financially.

Post Offices and banks

Nick Wright agreed that post offices and banks were very important to our communities, particularly when there were no other alternative facilities close by. It was noted that following a motion of full Council Nick Wright had written to all the banks in the District expressing the importance of their branches to our residents.

6. OPEN FORUM

Parish councils were invited to ask questions and raise any matters of importance.

Please can you give us an update the changes to the rules regard Section 106 agreements?

Councillor Robert Turner explained that for development sites of 10 properties or less, and which have a maximum combined gross floor space of 1000 square metres, the Government's Guidance is as follows:

 no affordable housing provision should be sought irrespective of whether it is an on-site provision or payment of a commuted sum in lieu no tariff style contributions should be sought (in the case of SCDC this covers matters such as an open space off-site contribution and/or an off-site Community Facilities Contribution) but it will also cover no contributions for Education and/or Health provision

Councillor Robert Turner explained the need for affordable housing in the District was so exceptional as to outweigh, in many cases, the Government Guidance and so the Council was continuing to seek affordable housing on schemes below threshold.

It was noted that the Community Infrastructure Levy would be replacing Section 106 Agreements after the Local Plan was agreed.

Please can you explain what the purpose was of the Open Space questionnaire?

Robert Turner explained that the Playing Pitch Strategy was commissioned by Cambridge City Council, South Cambs District Council and Cambridgeshire County Council.

The Playing Pitch Strategy will help:

- (a) guide implementation of the Local Plans that are currently under examination,
- (b) inform the planning of proposed development sites, and
- (c) assist future facilities planning.

The first stage of developing a strategy has been to quantify the current supply of sports pitches in both Cambridge and South Cambridgeshire. This includes an assessment of quality.

For this project, sports pitches includes grass, synthetic, floodlit, competition and indoor and outdoor training facilities for:

- Football
- Hockey
- Cricket
- Rugby

This work also builds upon existing information e.g. the South Cambs Recreation Study that was completed in 2013.

The consultants are currently trying to finalise the first stage. This has been delayed slightly because of the response rate required to make the study as robust as possible. The second stage is to provide an analysis of future demand across the area. A final report will be provided to project board at this stage.

In addition to the three Councils, the project board includes Living Sport, Sport England and Cambridgeshire Football Association.

Please can you ensure better feedback is provided to the parish councils when the District Council makes a planning decision contrary to the parish council's wishes?

Councillor Lynda Harford, Chairman of the Planning Committee, explained that the Council were required to make decisions that comply with planning policy and this might go against the wishes of local residents. The parish clerk should receive a copy of the decision notice. It was recommended that if the parish council was unhappy with the level of feedback provided that they ask the local district councillor to contact the planning department on their behalf. Parish councils were also reminded that they had the opportunity to speak at Planning Committee on any applications in their parish.

What can be done to improve the accuracy of the records on parish councils on the Council's website?

Parish councils can contact <u>democratic.services@scambs.gov.uk</u> to have their membership records amended.

What could be done regarding the cost of public notices with regard to tree removal?

The frustration of parish councils with this legal requirement was recognised.

It was agreed that the District's local MPs should be invited to the next liaison meeting.

Parking Charge Introduction - Busway Park & Ride sites St.Ives and Longstanton

Installation of parking payment system

The current timetable for the introduction of the new charging system will see the charges being introduced in April 2015. At present posters at the sites and the County Council's webpages state that the charges will be introduced in April. Once the technical testing has been completed a firm date will be announced.

Further posters together with leaflets explaining the system will also be displayed in March and leaflets handed out to passengers to ensure they are aware of the charges and also aware of the option to pay on-line. Additional information will be placed on the Busway buses, website and the press leading up to the launch..

An explanation of the charging system is contained below:

Schedule of Charges

All vehicles parking at either of the 2 Busway Park & Ride sites will have a 1 hour free period. This will enable people to drop-off and pick-up for free. Any vehicles staying for more than 1 hour will be liable for a £1 charge. This will be purchased from new ticket machines outside the main building at Longstanton or from the car park/edge of the concourse at St.lves. These are separate from the existing ticket machines used to purchase the bus ticket on the platforms. The receipt does not need to be displayed in the vehicle.

The £1 ticket will allow for the parking of one vehicle for up to 18 hours. Should the customer wish to park for longer there is a set tariff of charging as follows:

Between 18 and 24 hours £10

Between 24 and 48 hours £20

Between 48 and 72 hours £30

72 hours is the maximum permitted stay.

Discounts are available for those wishing to purchase parking in advance on-line or via a mobile phone. The prices for between 1 and 18 hours parking are as follows:

Weekly £5 (up to 7 days) 4 Weekly £18 Annual £230

A Bill Per Usage option is also available online which bills automatically, a month in arrears for the number of times a customer has used the car park. This website is currently used for the Cambridge Park & Ride sites and will be modified to include both additional car parks from the middle of March.
