# September 2015 parish e-bulletin – news and information from South Cambridgeshire District Council

Welcome to the latest parish e-bulletin. As in every edition, this one includes information that parish councils may want to discuss, important notices we want you to be aware of, as well as news from around the district.

#### 1) All out elections from 2018 – district and parish councils

Thank you to those parish councils who responded to our consultation on moving to all out elections. At a special meeting on 24 September, Council decided that from May 2018, all District Council seats will be contested at the same time every four years.

As part of our consultation, we stated that a move to all-out elections could potentially lead to all Parish Council elections also being held once every four years, on the same day as District Council elections. Council has decided that this will happen from May 2018, saving parish councils from the expense of standalone elections and increasing the likelihood of a higher turnout.

These changes will not take effect until 2018, so any parish elections scheduled for 2016 will still happen as planned. No parish council elections were due to be held in 2017. An order will be made by Council shortening the term of office for all parish councillors to allow all seats to be contested in 2018.

#### 6) Section 106 update

You may have recently heard or read about changes that have taken place with developer contributions (section 106 agreements). We have produced a <u>one page guide</u> explaining the current

position and setting out how you can help. We would encourage everyone to take a look so that we can ensure that developers continue to pay their share.

For background, last November Government moved to introduce a new national threshold on section 106 agreements. Then there was the pooled contribution restrictions (sometimes called the 'rule of 5') that came into force on 6 April 2015 as a result of s123 of the CIL Regulations. Although the national threshold has been withdrawn following successful legal challenge, the pooling restriction remains in force. This means that until CIL is adopted we will be relying heavily on Parish Councils to help secure developer contributions.

#### 7) Neighbourhood Planning Workshop

A Neighbourhood Planning workshop has been organised for **Wednesday 11 November 2015 from 6pm to 9pm** at South Cambridgeshire Hall. The workshop is for parish councillors representing designated Neighbourhood Areas with Neighbourhood Plans underway, and parishes that are seriously considering undertaking a Neighbourhood Plan.

There will be short informative sessions on: Community Land Trusts, self-build and affordable housing, design and conservation, a rural Neighbourhood Plan case study which has passed the referendum stage, and a Q and A session with the panel of speakers.

#### 8) Neighbourhood planning consultation

A four week consultation on three proposed neighbourhood areas is set to run from Friday 2 October. Foxton, West Wickham and Cottenham Parish Councils have all applied to have their parishes designated as Neighbourhood Areas. If approved, they will be able to develop a Neighbourhood Plan - a community-led initiative that includes a shared vision for their area. These plans can set out policies on the development and use of land in a parish or 'Neighbourhood Area' and have formal weight in deciding planning applications.
