3. Our **Mission** is to provide a 24/7 pre-hospital emergency medical service through the provision of pre-hospital critical care and retrieval by land or air, by supporting training programmes for Doctors and Paramedics and by conducting research and development activity.

Our **Vision** is to:

- save lives and reduce disability by the rapid provision of on-the-spot emergency medical expertise wherever the need arises within the East of England.
- use our expertise to promote excellence in the provision, delivery and development of the Pre-Hospital Emergency Medical care across the UK.

Our **Values** are about Quality Care, Compassion, Accountability and Professionalism in everything we do.

Our **Beliefs** are:

- The clinical service should be driven by patient need and evidenced based practice
- Value adding to existing clinical services
- Working in partnership with other NHS and charity clinical service providers
- Education, training and research at the heart of what we do

4. Membership

Magpas has approximately 200 members at any time. Membership is open to current Helimedix, medical practitioners (including doctors, nurses and paramedics) who have been clinically-active with Magpas in the previous three years and the Directors and former Directors of the charity. Members are able to vote at the AGM on issues such as the Annual Accounts and strategic direction of the charity. Membership is currently limited to individuals who fall into one of these categories in order to maintain a strong clinical focus and knowledge of pre-hospital emergency medicine (PHEM).

6. Magpas is currently available to provide life-saving service for 138 hours per week. With the support of Huntingdon Town Council we will be able to extend this service by an additional 30 hours to create a 24/7 service. This will ensure we are available to support local people who find themselves in a medical emergency all day, every day. We would be hugely grateful if Huntingdon Town Council would support Magpas to support this vital expansion of our work in 2015. We are requesting support towards the non-salary costs of this expansion including vital medicine, operational equipment and medical consumables.

7. Magpas relies on voluntary income to fund our work. We currently receive no direct government or lottery funding and, unlike many other Air Ambulance charities, we also do not receive any funding towards staffing costs from our local NHS Ambulance Trust. We have recently embarked on a proactive round of applications to local Town Councils, Trusts and Foundations to fund the expansion of our work and expect the outcomes over the coming months.

8. Magpas is an award-winning medical charity (reg. charity no. 1119279) which provides emergency, life-saving care to critically ill and injured people.

Care Act Implementation: April 2015

The purpose of this document is to ensure that you are able to direct people to resources where they can access the information and advice they need.

The Care Act is the most significant change to adult social care in over 60 years. It will modernise care and support in law so that the system is built around people's needs and what they want to achieve in their lives.

In Cambridgeshire, the Care Act is being delivered through 'Transforming Lives', a new strategic approach to social work and social care for adults which will change the way the council provides support to individuals, carers, families and communities within Cambridgeshire.

What we mean by 'care and support'

'Care and support' is the help some adults need to live their life as well as possible with any illness or disability they may have, and to stay independent for as long as possible. It may include help with things like washing, dressing, eating, getting out and about, and keeping in touch with friends or family. Adult social care provides advice and services to people who may need help because of their age, a physical disability, sensory impairment, a learning disability, or a mental health issue.

Many people don't think about social care until they or someone they know need support, and then they find they are unsure about where to find information and how to access the services they need. Anyone who thinks they have care and support needs can ask the council for a needs assessment.

Information and advice signposting

The Care Act sees **information and advice as fundamental** in enabling people to make choices about care and support for themselves or those they care for; to promote health and wellbeing; and support people to help prevent, reduce or delay care needs.



Information and Advice for Carers

The Care Act gives adult unpaid carers the same legal rights as the people they care for. Carers Trust Cambridgeshire has been contracted to provide a countywide adult carer support service on behalf of the County Council from 1 April 2015 for three years. They will be responsible for a range of things including, statutory assessments, including assessing eligibility and agreeing personal budgets for carers who are unknown to the council, carers of people who are self-funders using home care, and young carers who will continue in their caring role after 18; and for delivering an information, advice and prevention service which promotes and increases the wellbeing of carers.

New carers emergency contact scheme

Carers Trust Cambridgeshire will co-ordinate and run a new universal contingency scheme from 1 April 2015. This has replaced the Individual Carers Emergency Respite (ICER) Scheme for new people wishing to register. Carers with an existing ICER plan will remain on the scheme until their review when they will transfer to the new emergency contact scheme.

Safeguarding

From 1 April 2015 safeguarding will be on a statutory footing and local authorities are required to have a Safeguarding Adults Board and make or arrange for safeguarding enquiries to be undertaken. The categories of abuse have been extended to include modern slavery, domestic abuse and self-neglect. To mark the change an independent chair is being recruited to lead the Safeguarding Adults Board and hold all partners to account. The guidance underpinning the Care Act requires the implementation of the government initiative 'Making Safeguarding Personal'. For more information visit:
