Public consultation: Should South Cambridgeshire District Council use article 4 directions to help retain village pubs?

Article 4 directions could be used to withdraw the permitted development rights which currently allow their conversion to other uses such as retail or offices, or for their demolition. An article 4 direction does not prevent the development but does require planning permission for the development to be obtained first.

South Cambridgeshire District Council is seeking views concerning the proposed use of article 4 directions to help retain village pubs.

The results of this consultation will help us decide whether article 4 directions provide an appropriate tool to achieve this and to identify specific rural pubs where the use of an article 4 direction would be appropriate.

What is an article 4 direction?

Article 4 directions allow the local planning authority to withdraw permitted development rights which would otherwise apply. At present a pub can change its use to a shop or an office, for example, without the need to seek planning permission. An article 4 direction does not prevent the development to which it applies, but instead requires that planning permission is first obtained for that development.

Should the district council apply article 4 directions to remove permitted development rights and require submission of a full planning application under any of the following circumstances?

a) When it is thought demolition of a particular pub would undermine the look and feel of an area in which the particular pub is located (when the pub is outside a conservation area).

Dear Mr Vickery,

I am writing on behalf of the Cambridge & District branch of CAMRA (Campaign for Real Ale). The majority of South Cambridgeshire falls within our branch area.

Please could you bring to the attention of Cambourne Parish Council a public consultation that South Cambridgeshire District Council (SCDC) is currently holding on the potential use of Article 4 Directions to prevent pub losses either through change of use or through demolition. The conversion last year of the Pear Tree Hildersham to an on-line furniture business without the need for planning permission highlighted the issue in South Cambridgeshire. CAMRA believes that no pub should be lost through change of use or through demolition without it first being subjected to the scrutiny of a planning system that allows the public to express their views. We have urged local authorities to use Article 4 Directions to bring this about. SCDC are consulting on doing just that. For more details please visit their webpage https://www.scambs.gov.uk/content/consultation-greater-protection-public-houses I also attach an article that will be appearing in the next edition of our ALE magazine.

Although we have no reason to believe that The Fox is under any current threat we do believe that pub losses should be regulated by the planning system and would urge Cambourne Parish Council to make a submission to SCDC.
