**Subject:** South Cambridgeshire Local Plan – Appointment of Inspector and Commencement of Examination Hearings

Dear Sir / Madam

I am writing to inform you that the Secretary of State has appointed an Inspector to examine the South Cambridgeshire Local Plan that was submitted in March 2014 and to advise you of the commencement of the examination hearing sessions. The Council is required by national regulations to notify every person who made representations to the Proposed Submission Local Plan consultation held between July and October 2013 about these matters.

The Secretary of State has appointed Inspector **Miss Laura Graham** BSc MA MRTPI and Assistant Inspector, **Alan Wood** MSC FRICS, to hold the examinations into the Cambridge Local Plan and South Cambridgeshire Local Plan. They are being assisted by a Planning Officer, **Laura O'Brien**, who is employed by the Planning Inspectorate, and Programme Officer, **Gloria Alexander**.

The first block of hearing sessions will begin on **Tuesday 4 November** at 10.00am. It will cover joint issues for both Local Plans and will take place in the Council Chamber at South Cambridgeshire District Council's offices at South Cambridgeshire Hall, Cambourne Business Park, Cambourne, CB23 6EA.

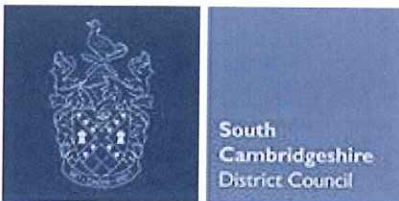
