#### 1. APOLOGIES

Apologies for absence were received from, Cllr Mrs L Doidge, Cllr P Gavigan and Cllr Mrs L Selway.

# 2. MEMBERS DECLARATION OF INTEREST OR REQUEST FOR DISPENSATION for items on the agenda.

There were no declarations of interest or requests for dispensation.

#### 3. CHAIRMAN'S ANNOUNCEMENTS

The Chairman made no announcements.

#### 4. TRANSPORT INFRASTRUCTURE

At the November Council meeting issues were raised by a resident regarding bus stops in Cambourne and it was agreed that this would be raised with MCA at this Special Council meeting. The concerns raised were regarding the lack of hardstanding between the footpath and the kerb and that in order to board the bus a grass verge must be crossed. In the winter this will damage the grass and the areas concerned will become very muddy and difficult for buggies and wheelchairs. The second issue concerned cars parking too near the bus stops so that buses are unable to stop at the designated place.

Bryn Maidman confirmed that MCA would be happy to install hardstandings at the bus stops concerned as long as there were no issues with the Highways Authority or with adoption. It was requested that the hardstandings be sufficiently wide for a wheelchair. Bryn Maidman also confirmed that MCA had no objection to the installation of yellow bus stop markings and would discuss their installation with D A Cant again as long as there were no issues with the Highways Authority and that they were enforceable. The Parish Clerk will supply MCA with a map showing the bus stops concerned and provide photographs of the various locations.

Concerns were raised reading the unreliability of the Stagecoach Citi 4 service and the cancelling of services. Bryn Maidman confirmed he would arrange a meeting with Andy Campbell at Stagecoach to discuss the issues. It was requested that a copy of the DRT timetable be put in the Library as currently there is not one there. It was also noted that the Upper Cambourne Travel Pack contains some errors which have been passed onto Taylor Wimpey; Bryn Maidman requested that a copy of the comments be forwarded to him.

The Parish Clerk reported that there was a need for a shelter at the bus stop on Cambridge Road and requested that once the shelter near the Building Society is removed it could be relocated. Bryn Maidman confirmed that he had no objections to this.
