COUNCIL MEETING 7th July 2009

Transfer meeting: 2nd July 2009.

1. Temporary Third Primary School: Parish Council has returned the Documents duly signed.

Permanent Third School: the Jeavons Lane site is in the same S106 pot and is subject to the viability study. Nick Smith is keen to move it on and progress is being made they are keen to pass it over asap.

An alternative option is been discussed with the County so the land can be released outside of the S106.

- 2. Bowling Green: The new PR company will take this on and liaise with the Parish Clerk on the opening event. McA will provide a budget of up to £1,000 for the event.
- 3. Allotments Phase 2: the draft documents have been agreed and returned for engrossment. There are now a lot of weeds growing on the allotments. There are over 34 people on the waiting list currently who want to get access to the site. It would be helpful if the Parish Council could gain access to mark out the allotments prior to transfer so they can be let straight away. Neville Stebbing agreed to look to see if this was possible. The only outstanding issue is the maintenance money which has to be agreed.
- 4. Cricket Pitch and Square. Cricket Pitch trial matches have been agreed with Randall Thorpe and Tony Leach if these prove safe to play. Therefore the provision of the pavilion should be brought forward even if the construction has to be phased as there was a commitment from McA to provide pavilions at Great and Upper Cambourne these are to be combined on the Great Cambourne site.

Pavilion There is a distinct lack of facilities in Cambourne; therefore the provision of the pavilion is urgent. There is a commitment from McA to

provide pavilions at Great and Upper Cambourne these should be combined on the Great Cambourne site.

There is a need for additional toilets and more temporary changing facilities. Neville asked that we bear with McA as they are trying to resolve the provision in tandem with the sports centre.

- 5. Sports Centre: this is still being pursued there is a further meeting at 11.00am 6th July 2009 at SCDC to consider further information. The intension is to commence construction this year.
 - **Maintenance Building:** Neville was requested to release the land so the Parish Council could proceed with the project if it so wished.
- 6. Scout Hut Land. The documents have been signed and returned along with the agreement for the Bryant's area. The only outstanding issue is the maintenance money which has to be agreed for the access road and the release of the £2,500 for the construction of toilets on the allotments. The subject of the MUGA toilets and there re-siting at the allotments was discussed further and Neville agreed to look into ownership.
- 7. **High Street** A retail consultant has been appointed to review the High Street design they will be looking at the Care Home as well.

 McA support the District Councils view point as it is important to have a viable vibrant settlement centre.
- **8. Verges adjacent to School Lane:** Neville agreed to progress these.
- **9. Entrance Island:** Neville agreed to look at this subject to them being kept to the same standard as at present.

10. AOB

- Bus shelters:- there has been no further progress.
- Adoption of roads:- they are very advanced technically, but the paperwork is not as advanced. Steps are being taken to address this.
- Concern was raised about the Developers land and litter especially Upper Cambourne Green; this has also been raised by Neville Stebbing and South Cambs District Council and will be looked into as it is not satisfactory.
- Pumping Station:- This is being monitored, but the conditions are not right at the current time.
- 950 additional houses and 106:- the viability study is continuing.
- Secondary School and Fourth Primary School there has been a number of meetings with Ian Trafford of the County Council on this matter. The County Council has agreed a preliminary design and subject to the owner's consent.

- The bridal way including Crowdean around the southern boundary to The Vine School has been dedicated.
