#### 8. COUNTY COUNCIL MATTERS

County Councillor Lister Wilson for Cambourne reported that:

The HCV map circulated was actually for consultation. The HCV routes did not come through Cambourne.

Concern was raised about HCV using Cambourne as a short cut when the Caxton roundabout was closed.

The settlement from Central Government is for a 2.2% increase the lowest in the Country. The County is working on the budget now, but the

settlement makes it very tight.

Secondary and Fourth Primary School work is on going with negotiations on the land progressing.

Third Primary School, the County Council is wary of Compulsorily purchasing the site for the School Lister is putting pressure on the County and they are aware of the problems and how urgently the permanent school is needed.

Healthcare issues residents are waiting a long time for appointments, the situation appears to be getting worse.

Transfer meeting: 26<sup>th</sup> November 2009.

1. **Sports Centre:** Negotiations are ongoing between McA and an operator for the sports the aim is to jointly devise a design that meets the s106/Sport England/ Parish Council. McA will then commission the build of the centre, to be managed by the operator. The design currently includes external changing and a club room overlooking the pitches.

The end date for provision will be at the end of 2011 allowing for Legal, Planning, Building Control, tendering, construction, fitting out and training the staff for the Centre.

Nick Smith is working hard on the sports centre.

McA has entered into a guarantee with South Cambs District Council to give reassurance on delivery of the Sports Centre.

2. **Pavilion:** It is difficult to progress this independently of the Sports Centre as some of the provision may be offset by that in the Sports Centre. McA consider that there is one pot of money for sport from which the Sports Centre and Pavilion comes.

It was raised that due to the delay in delivery of the Sports Centre and uncertainty over the Pavilion that McA should look at the provision of temporary changing facility asap Neville agreed to look into this. The Parish Clerk to liaise with the sports clubs and Neville on the exact requirements.

3. **Permanent Third Primary School:** the Jeavons Lane site is subject to the viability study for the additional 950 homes. The site is not an obligation, but is a sensible gift. McA are discussing options with the LEA re use of the site. There is a pressing need as there is limited space on

the site to fit all the year groups on the site. The viability study should be submitted shortly.

- 4. **Secondary and Forth Primary Schools:** At a meeting between McA and the LEA, it was reported that funding is not yet certain. The Parish Council has a meeting with the LEA and Architects on the 8<sup>th</sup> December 2009 to discuss the new school
- 5. **Allotments Phase 2:** the water main has finally been located; Cambridge Water did not have a record of its location. McA are working towards transferring the Allotments by the end of the year.
- 6. **Cricket Pitch and Square**. McA are aiming for this to be transferred January/February.
- 7. **Scout Hut Land.** McA are aiming for this to be transferred January/February. Outstanding issues are being chased up.
- 8. **High Street** Nick Smith is working on this and as part of the review they are looking at re-siting the Care home to the site opposite the Library/Medical Centre. This will make the rest of the High Street more attractive. The planning application for the Fire Station is due early next year.
- 9. **Verges adjacent to School Lane:** At the moment this is going to be maintained by McA within the new Tilbrook contract to keep it a reasonable size for them.
- 10. **Entrance Island:** At the moment this is going to be maintained by McA within the new Tilbrook contract to keep it a reasonable size for them.
- 11. **950 Additional Homes and s106:** the Viability model is ready for submission by McA.
- 12. **Adoption of Roads:** McA are working with the County Council to get Broad Street/High Street adopted in January 2010. Morrisons have agreed to dedicating part of their path as Highway.

Then it will be

- Monkfield Lane and part Jeavons Lane
- Swansley Lane and Woodfield Lane
- Greenhaze Lane
- 13. **Drains in Cambourne:** Smelly drains they believe they have resolved the problem after a meeting with Environmental Health. It stems from the pumping station at Upper Cambourne being not used as regularly as others the foul water is sitting in the pump chamber for longer than other

areas which means that stale air is being pushed ahead of the foul water. The manholes have been greased to seal them to minimise the air escaping.

**Pumping Station:** A lot of work has been carried including the installation of flow meters to identify high flow points when it rains so the problem areas can be isolated. This takes time as the flow rates during dry periods have to be compared to high rain fall periods.

- 14. **Busses:** McA have stopped paying the subsidy for the Citi 4 bus (they were paying £2,000/month this was increased to £4,000/month about 18months ago after some complaints). McA had carried on paying longer than required.
- 15. **Date of next meeting** T.B.A
