7. DRAFT UPPER CAMBOURNE INFORMATION PACK

The following concerns were raised:

Page 2 – Walking & Cycling - There is no explanation of the red cycle routes available through Cambourne.

Page 3 – Map 1 Walking & Cycling Routes – There is no cycling route to the Secondary School and the new cycle route on Swansley Lane is not shown.

Page 7 –Public Transport - It is not identified which bus routes are accessible to wheelchair users. There should be a reference to the Concessionary Fare Scheme.

Page 10 – Map 3 Bus Services – Not all bus stops are marked, only those on one side of the roads i.e. School Lane

Pages 11 – Rail Services – There is no mention of concessions or of disable access to Rail Services. A link to the relevant website would be helpful and an explanation of where on the page to find the information.

Page12 – Taxi Card Scheme – It should be clearer that this is for people with mobility impairments.

Page 13 – Should include information on how to apply for a blue badge. Other information such as that on Concessionary fares could also be included on this page with links to relevant websites.
