3 What are the objectives of your organisation?

ISKCON as an organisation aims to share the Ancient Knowledge of Life Management / Stress Management/ Meditation (Kirtan) and make this available for all irrespective of cast/ colour/ background for free. The main aim of our Cambourne Group is to engage individuals in spiritual development and assist this process by holding Community based festivals and celebration events (open to all).

The main 7 Aims of the organisation as a whole are as below:

- 1. To systematically propagate spiritual knowledge to society at large and to educate all people in the techniques of spiritual life in order to check the imbalance of values in life and to achieve real unity and peace in the world.
- 2. To propagate a consciousness of Krishna (God), as it is revealed in the great scriptures of India, *Bhagavad-gita* and *Srimad-Bhagavatam*.
- 3. To bring the members of the Society together with each other and nearer to Krishna, the prime entity, thus developing the idea within the members, and humanity at large, that each soul is part and parcel of the quality of Godhead (Krishna).
- 4. To teach and encourage the *sankirtana* movement, congregational chanting of the holy name of God, as revealed in the teachings of Lord Sri Caitanya

Mahaprabhu.

- 5. To erect for the members and for society at large a holy place of transcendental pastimes dedicated to the personality of Krishna.
- 6. To bring the members closer together for the purpose of teaching a simpler, more natural way of life.
- 7. With a view towards achieving the aforementioned purposes, to publish and distribute periodicals, magazines, books and other writings

This application is to assist in running the larger event (Janmashtami) on 15th September as well as another couple events before this.

We wish to apply for this grant as our main aim is to include as many people as possible. If there is an admission cost then this might prevent the individuals with limited means to attend. The grant will assist us in keeping this a free event.

Grant will be used for the following expenses

- 1) Hall Hire (£300+)
- 2) Cost of Disposables (Plates/cups/ spoons etc..) (£100)
- 3) Cost of visiting musician transport (they usually do not charge us)(£100)
- 4) Kids drama costumes/ hall hire for practice sessions before event (£200)
- 5) Catering costs (food and drinks various preparations) (£400+)

We all volunteer our time and efforts to ensure all get a chance to work together.

We have never requested any funding support before- and have ran it using voluntary contribution as well as funding the costs ourselves. This is the first time we have applied as the events are very well received and
