I have been approached by Sarah Jarman at Monkfield Park Primary regarding a parking issue. As you are aware, parents and guardians are parking at, and near to, the school car park entrance to drop off and collect their children. Sarah has requested bollards be placed in this area to discourage drivers from doing this. I have, as you will see below, spoken to the County Council and they have suggested a Privately Funded High way Improvement (PFHI) application or a LHI bid. Is this something the Parish is willing to be involved in? I really do appreciate that you are already supporting the school and you have given bollards as a temporary deterrent. What I was hope is the three of us could work together on a more permanent basis.
