1. APOLOGIES

A presentation was received from Rebecca Neal, Communities & Wildlife Officer from The Wildlife Trust.

Rebecca gave an overview of her role and what activities The Wildlife Trust, plan on holding and carrying out over the next year. A focus on including schools and families in the community was highlighted. An update was given in regard to the Cambourne To Be Wild event, which will be held on $19^{th} - 20^{th}$ June 2020, following on from this year's event. Feedback and suggestions have been received and next year's event will be bigger and better, with more activities for children and families, but following a slightly different format, with the Friday evening more for adults and the Saturday being family centred, with more activities and no Sunday event.

The new blinds in the Hub Main Hall were fitted on the 23rd October 2019 and have been greatly appreciated by hirers.

Contractors have begun repair works at The Blue School and have fixed issues with the toilets between Classrooms 1 and 2 and works on the stairs and ramp at the front of the school began on the November 12th 19. Hirers of the Blue School were informed of the repairs and were told about alternative entrances to use. Next, they will be working on the heating manifolds and servicing the plumbing, heating, Electrical, Fire etc. They were planning to be in a position for a transfer at the end of November this is now likely to be December 2019 or January 2020.

Cambourne Youth Partnership Report to Town Council: November 2019

The report below covers the key points of the ongoing CYP/Romsey Mill programme of activities for 2019-20 along with any relevant future plans. Some of the details provided in the June 2019 report have not been repeated.

Staffing:

Jonathan Buwert (lead development worker): 2.5 days per week in Cambourne clubs and activities, including time spent running training courses for Romsey Mill at Cambourne Soul, in which Cambourne young leaders and volunteers are involved. (Two new local volunteers have started in autumn term.)

Justin Lewis: 3 days per week, leading on Monday club (Years 9-11), music sessions (Thursday/Friday) and Boxing (Thursday).

Emma Slater: increase to 3 days per week, leading on two clubs on Wednesday (Year 7 & Year 11+) and Friday (Years 8-9).

Justin and Emma are also doing regular detached work and becoming more well-known to young people in Cambourne. All three youth workers are involved in one-to-one meetings with young people at various times.

Summer programme: staff and volunteers continued to run a weekly open access club at the Soul Building throughout the summer, as well as organising some trips out. In addition, a number of young people attended a residential.

Soccer: Friday soccer continues with Neil Thompson (trustee) and a volunteer; there is discussion about starting a girls' soccer group to be led by Justin Lewis and a volunteer (possibly also Friday) - Justin is undertaking an FA coaching training course.

Wysing Arts: plan to start monthly arts group on a Saturday, with approx. capacity for two groups of 12, supported by Len Thornton (trustee) and a volunteer, with Wysing Arts providing materials and expertise. The aim would be to create a defined end product at each session.

Music: further investment has been made in the equipment in the music recording studio in order to improve opportunities for young people to create and record music.

Co-op Community Fund: application to this grant fund has been successful; if people register CYP as their chosen charity, 1% of cost of Co-op products will go to CYP.

Networking: Jonathan remains in contact with the police and the local 'early help team' to try and coordinate support for young people in Cambourne area.

Cambourne Village College links: Jonathan continues some 1:1 work in school; he has been asked to work with some Year 7&8 pupils who are now also attending Soul clubs. Jonathan is also liaising with former police sergeant Phil Priestley (currently also being employed by Cambourne VC) to coordinate work with young people more effectively.

Scope and growth of youth work in Cambourne over the last two years

Cambourne Youth Partnership has worked in partnership with the charity Romsey Mill since youth work was established in 2007. Over the last two years Romsey Mill has made a significant extra financial investment in youthwork in Cambourne (alongside the money received from the Town Council and Section 106 developers), leading to a notable expansion in the youth worker hours available, and consequently an increase in the number of clubs and activities, as well as the number of young people who benefit from them.

Alongside this report, you will receive the annual report on youthwork in Cambourne produced by Romsey Mill for the period September 2018 to August 2019. This report gives a comprehensive overview of activities, the number of young people involved and the commitment of both paid staff and volunteers to enable this to happen.

The expansion of youthwork over the last two years can be demonstrated by comparing the figures from this 2018-19 report with those from the period 2016 - 2017. One of the most encouraging developments has been the training of young leaders and volunteers which has enabled us to guarantee the staffing of a wider range of clubs and activities over more evenings in the week.

Looking ahead:

Recent expansion has been possible owing to Romsey Mill's successful application to the Youth Investment Fund (YIF) for a three year grant to expand youth work. This grant will come to an end in April 2020 and YIF will no longer exist. This means that unless Romsey Mill is able to make successful applications to other grant-making bodies to replace some or all of this income, our income to support youth work in Cambourne will reduce sharply and we will have to curtail our current level of activities. Up until this point in time, CYP youth work has been financed from the Town Council (£20,000 pa) and from historic Section 106 developer funding (approx. £10,000 pa), but this Section 106 funding will end in April 2020. Over the last two years, Romsey Mill has made a financial contribution which has more than doubled this figure of £30,000. A more detailed budget will be provided to the Town Council in the near future.

How much money can the Town Council commit to youth work in Cambourne in 2020-21 and the following years? Will any Section 106 money from West Cambourne become available for the revenue funding of youth work from April 2020?

We would also be grateful to learn of progress in discussions with the South Cambridgeshire District Council about a loan to enable the building of the new youth centre for which planning permission was gained 18 months ago. The current premises are clearly inadequate for the scale of youthwork now being provided.
