### 4. CHAIRMAN'S ANNOUNCEMENTS

The new LDF update came out this evening and there are no consultations that affect Cambourne.

The Chairman felt inclined to push forward getting a speed watch group set up, to protect residents after a number of streetlights have been lost as a result of drivers speeding and taking bends too fast. The Town Council has previously had an invitation from the Local Constabulary to set a speed watch group up.



Equipment, such as a speed gun would be provided from the Local Constabulary and the group would receive training on how to use it.

The same application was commented on at the Planning Meeting on the 22<sup>nd</sup> October 2019 with the amendment of the description of the rear extension being removed from the application and the Councillors wished to put forward the same comments.

#### It was:

**RESOLVED** to object to the application, due to the detrimental effect of the design of the gable of the porch, on the street scene. As the main access to the property it should have a level access, or with a ramp.

<u>S/3530/19/DC</u> Discharge of conditions 5 (Materials-external surfaces) and 7 (Hard and soft landscaping) Pusuant to planning permission S/1685/19/FL

Location: Land Adj 4, High Street, Cambourne

Applicant: McCarthy Stones

A point was raised as to whether the trees that are adjacent to the High Street should have route barriers. It was stated if the trees are within 3m of services then they would need route barriers. It was put forward that perhaps all the trees will need route barriers and other protection, as the tree roots that are currently along the High Street path are raising the paving slabs and are becoming hazardous.

A comment was raised that the planned trees adjacent to the island on the High Street on the same side as the McCarthy Stone site should need re-siting as it could restrict the view for pedestrians crossing the road.

#### It was:

**RESOLVED** to receive the application and raise the above comments.

#### 7. TOWN PLAN

To consider the action plan relating to the Planning Committee.

The Town Clerk has drafted a planning process document for planning applications to clarify the Town Councils role, due to misinformation in the Cambourne Crier, which states that the Town Council "will ultimately approve or disapprove the plans" for the proposed High Street development. Andrew Thompson Planning Officer in Strategic Sites Team has added to the draft document with a full explanation of the planning process, this will be circulated as appropriate. An article will be submitted to the Cambourne Crier with the process, so residents can understand how planning applications are considered.

#### It was:

**RESOLVED** that the actions are ongoing and taken into account when considering items on the Agenda.
