

THE SCHEDULE

Description of highway to be stopped up

The highway to be stopped up is at Cambourne in the District of South Cambridgeshire, shown on the plan as:

- 1. A length and southern part width of the A1198. Commencing at grid reference E:530442 N:259304 (T1), it extends in a north westerly direction for a maximum distance of 402.2 metres. It has a maximum width of 144.1 metres (T5-T8). It is marked 1 on the plan.
- 2. A length and western part width of the A1198. Commencing at grid reference E:530022 N:259470 (T11), it extends in a north westerly direction for a maximum distance of 403.2 metres. It has a maximum width of 23.6 metres (T12-T13). It is marked 2 on the plan.
