Dear Joe.

Thank you for your email and interest in the East West Rail (EWR) project.

We are designing the railway to be able to accommodate freight, which means that the railway will be capable of freight operation. How much freight would use the railway is not yet known as this is subject to government policy and market demand and is likely to be affected by interventions on other parts of the rail network. We are studying the potential demand, the capacity considerations on EWR infrastructure, and the potential constraints elsewhere on the network. This work will inform the approach to the next stage of design and the assessment of the environmental impacts of the Project. Our current considerations on freight are available in more detail in the Technical Report <a href="here">here</a>. Further information, including how we will avoid or reduce impacts from freight, will be shared during the next consultation.

We look forward to engaging further with the local community and representatives of Cambourne Town Council during this non-statutory consultation. 




#### Q1 Do you support the need for a station at Cambourne?


#### Q2 Where would you prefer the station to be located?




