# **19.1 Yellow Line Consultation**

#### Questionnaire

The current survey was due to be closed at the end on the 28<sup>TH</sup> March 2021, but this was extended to the 31st March 2021

As of 1st April 2021

159 responses (16 Web, 15 Cambourne Crier & 116 Facebook)

There has been a high % of support for the three zones on the questionnaire (Jeavons Lane x2 and School lane).

Jeavons Lane (near to Jeavons Wood School)

Zone 1 91.82% Agree/Strongly Agree 1.89% Disagree/Strongly disagree

Jeavons Lane (from the tennis court down past the turning for Miller Way, Stagwell Road to Sitch Road).

Zone 2 76.73% Agree/Strongly Agree 10.06% Disagree/Strongly disagree

School Lane (extension to existing yellow lines).

Zone 3 91.82% Agree/Strongly Agree 4.40% Disagree/Strongly disagree

A fuller report on the full Questionnaire will be available after the survey closed on the 31st March 2021 has been fully analysed.

We have received two emails from residents regarding the yellow lines.

24 Hour Waiting Restrictions Proposal Zone 2

Further to our conversation earlier this week I confirm my opposition to Zone 2 of this proposal. I am a resident of Jeavons Lane and in my view the stretch between the tennis court and Miller Way does not have any traffic or parking issues. Cars are rarely parked on either side of the road on this section therefore pedestrian safety is not compromised. The road is sufficiently wide enough to allow safe access for emergency vehicles. For the infrequent events that take place on Great Cambourne Green traffic is already very well managed with temporary no parking cones. Best regards

I live at Jeavons Lane, at the corner of Mayfield Way. I would like to make the following observations as to the proposed double yellow lines extending from the tennis courts to Sitch Rd.

1/ I am not aware of any problems with parking, certainly not at my end of Jeavons Lane.

2/ Clearing parked cars from that stretch of Jeavons Lane, unusually straight for Cambourne, may have the effect of causing increased traffic speeds.

3/ The double yellow lines may just push the parking to side roads, and I have Mayfield Way in mind here.

# 19.2 Transfer of public transport function to Cambridgeshire and Peterborough Combined Authority

Dear Parish Clerk

As part of the Devolution Deal in 2017 that established the Cambridgeshire and Peterborough Combined Authority (CPCA) responsibility for Transport Authority functions transferred from Cambridgeshire County Council (CCC) and Peterborough City Council (PCC) to the CPCA. One of the areas that a Transport Authority is responsible for is any provision of public transport services, including contracted local bus services, community transport and concessionary travel. Since 2017, although the CPCA have been responsible for public transport they have delegated that responsibility to CCC and PCC to carry out the day-to-day delivery on their behalf. However, in October 2020 the CPCA notified both Council's that it intended to operate the day-to-day delivery directly. From 1st April, therefore, the current public transport functions will transfer from CCC and PCC and will be provided direct by the CPCA. The current provision of bus services, community transport and concessionary travel scheme arrangements will continue from 1st April and the public should see no change, apart from some contact details, to the services they use. Contact details are being finalised and those directly affected will be written to shortly.
