To whom this may concern

Dear all

I represent a small group of homeowners from Great, Lower and Upper Cambourne, who have great pride in our villages, communities and surroundings.

We have come together as we wish to voice our concerns about the urgent need to preserve and enhance the quality of Cambourne. It was once a shiny, new community, however, at around a quarter of a Century old, it is showing its age in many places and without action, will become further run down and very tired in the not too distant future. A plan of action is required, and we would like to encourage our Local Authority, elected representatives, the Parish Council, The Wildlife Trust etc to please liaise and either work together where possible or acknowledge individual responsibilities and suggest solutions, wether they be short term or over a longer period of time. Our concerns are that within the next decade, without a planned and accountable maintenance, replacement and improvement program in place, the fabric of Cambourne will become so dilapidated, that the task and cost required of raising it back to its original standard, will be practically unachievable.

In no particular order...

The blue lampposts were once a vibrant colour, yet and are now dull and flaking and in places covered in growth. Could a certain number of lampposts be painted every year?

Many public bins are severely corroded, in particular near the base. We believe this is in part may be due to the gardeners stripping the paint off the bins when they cut the grass around them. When bins are replaced or maintained, could they be raised on concrete plynths so that the gardeners do not damage them so easily?

The many blue signs and flag poles which were placed around Cambourne over twenty years ago, advertising developers and various locations, have deteriorated with time and are now unnecessary and redundant so could they all be removed? There are no new properties available for sale anywhere in Lower, Great or Upper Cambourne and all sales offices have been closed. Many of us have lived on a perpetual building site since moving to Cambourne. It would be good to finish it off.

There are multiple places in Cambourne, especially in paved areas, where trees have died, been removed, yet not replaced.

All over Cambourne the ground it littered with broken concrete utility markers. Who is responsible for these?

There are hundreds of rotten posts around Cambourne, at the edges of pavements and cycle paths, marking crossings.

There are many opportunities around Cambourne for tree planting, such as the plot where the old preschool was once located opposite the church. Could the Wildlife Trust help with a planting programme or are there any government grants or initiatives for community tree planting programmes?

Many of the wooden fences around Cambourne are rotting and falling apart. Could these at the very least be repaired and stained to give them a few more years life?

Is it permitted that unsightly advertising banners and signs for private businesses are put up around Cambourne?

The lacquer on many benches is flaking off and they are unsightly and require treatment to avoid going rotten. Could we have more benches around Cambourne? Simple wooden ones made with railway sleepers would be inexpensive, low maintenance, yet very welcome, especially around the lakes and beside paths.

There are only three covered bus shelters in Cambourne serving hundreds of students, schoolchildren, workers, retired people and others who travel by bus to Cambridge and St Neots. All three shelters are substandard and in poor condition. All other bus stops offer no protection from the elements at all. Can we not have modern, large, clear, graffiti resistant bus shelters that most other communities of our population size have?

Why are there so few pedestrian crossings in Cambourne? Hundreds of children have no choice but to cross busy roads on their way to and from primary and secondary schools every day. Traffic has increased dramatically over the years and there are an increasing number of impatient drivers speeding through Cambourne. We also have concerns for residents of the 53 new retirement apartments which will become occupied soon. We assume that most will be of retirement age, some may be elderly and others may have disabilities or mobility issues yet they will all need to cross a busy road to get to the chemist, doctor or supermarket. In Europe many villages have numerous pedestrian crossings at almost every junction. They are often just simple painted white stripes on the tarmac without the need for expensive traffic lights or beacons.

The Upper Cambourne roadsign (posts still there, opposite the cricket pavilion) has disappeared.

Please note that this email has been sent to our elected representatives, Member of Parliament, the Parish Council and The Wildlife Trust.

We urge you to please liaise with one another regarding the issues raised, however, would very much appreciate your individual responses.
