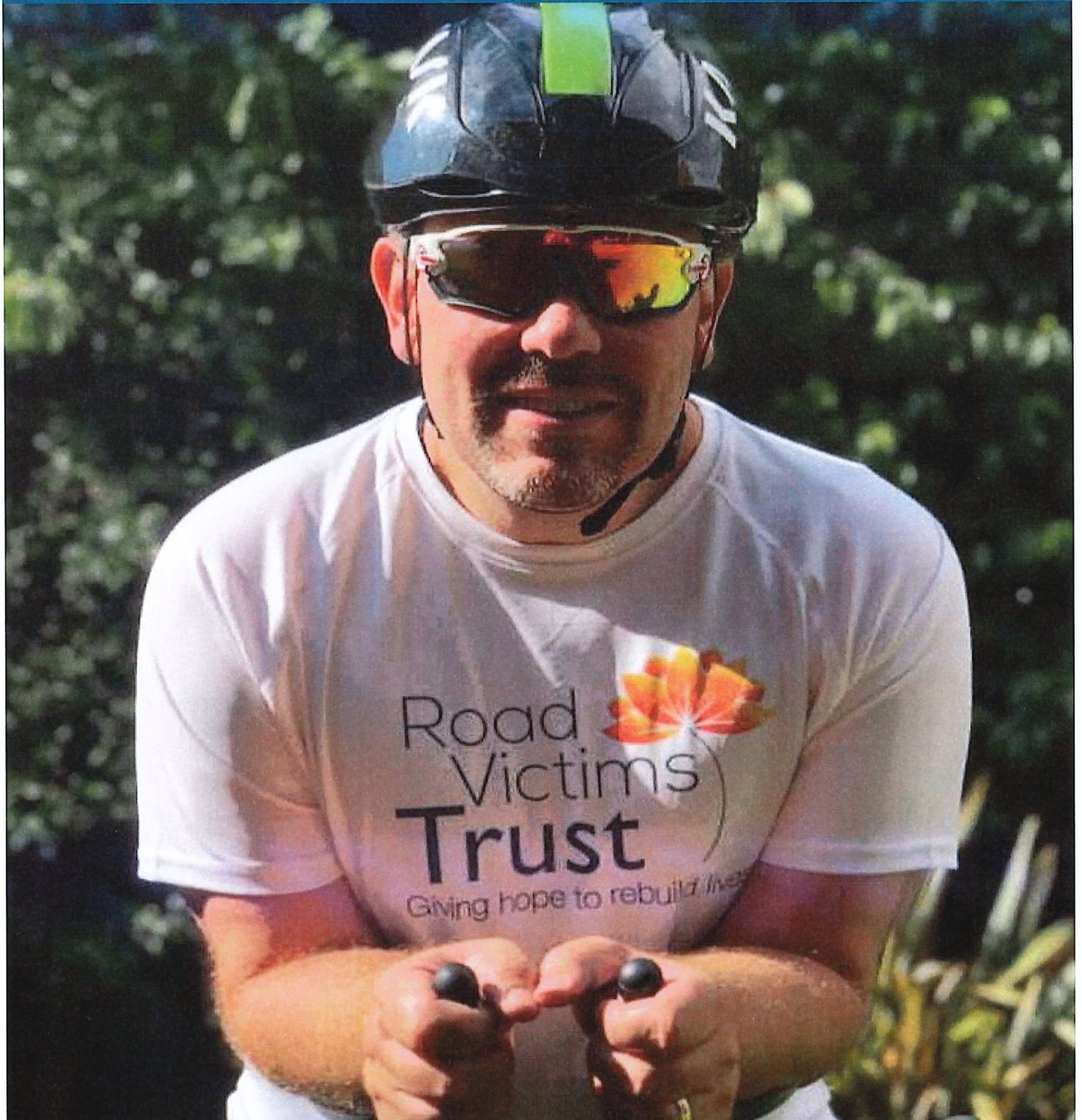

Despite the effects of lockdown and other restrictions on movement it remains a fact that each day at least 5 people will be killed on the roads of the United Kingdom with countless more seriously injured. Entire families will have their lives devastated in the most horrific of circumstances with a significant knock-on effect for the community as a whole. Road collisions continue to be the leading cause of death for people aged between 15-29 and yet the national picture in how victims are supported is patchy in the extreme.

The Road Victims Trust (RVT) has 27 years' experience of delivering extensive practical and emotional support to all victims of fatal and life-changing road collisions occurring in Bedfordshire, Cambridgeshire and Hertfordshire. The need to provide professional, effective and timely personal support to those affected by death or life changing injuries resulting from road collisions is key to helping those traumatised start to move to a point of beginning to cope with their experience.

The well-established and tried and tested formal Service Level and Information Sharing Agreements with the Bedfordshire, Cambridgeshire and Hertfordshire Police Forces and Offices of Police and Crime Commissioners allows for the very best levels of victim care delivered by a highly skilled and qualified team of Counsellors and Coordinators. Additionally the RVT is represented at both Strategic and Tactical level at the 3 County Road Safety Partnerships and are committed to the delivery of a Vision Zero Strategy that seeks to eliminate road death and significantly reduce life-changing injury collisions.

We firmly believe that the local commissioning of services, delivered by local people to local people, allows for the provision of the very best levels of victim care. The RVT sits on a national working party that is seeking to address the disparities that road victims face depending on the area that they live.

The RVT Service is delivered by a small team of paid staff who coordinate a cohort of 55 professional Counsellors who volunteer their time and expertise to support those bereaved or affected by a road death or life-changing injury.

Our thanks are extended to the entire team who work tirelessly alongside their Emergency Services and Road Safety partners to provide hope to rebuild the lives of those at their lowest possible ebb.

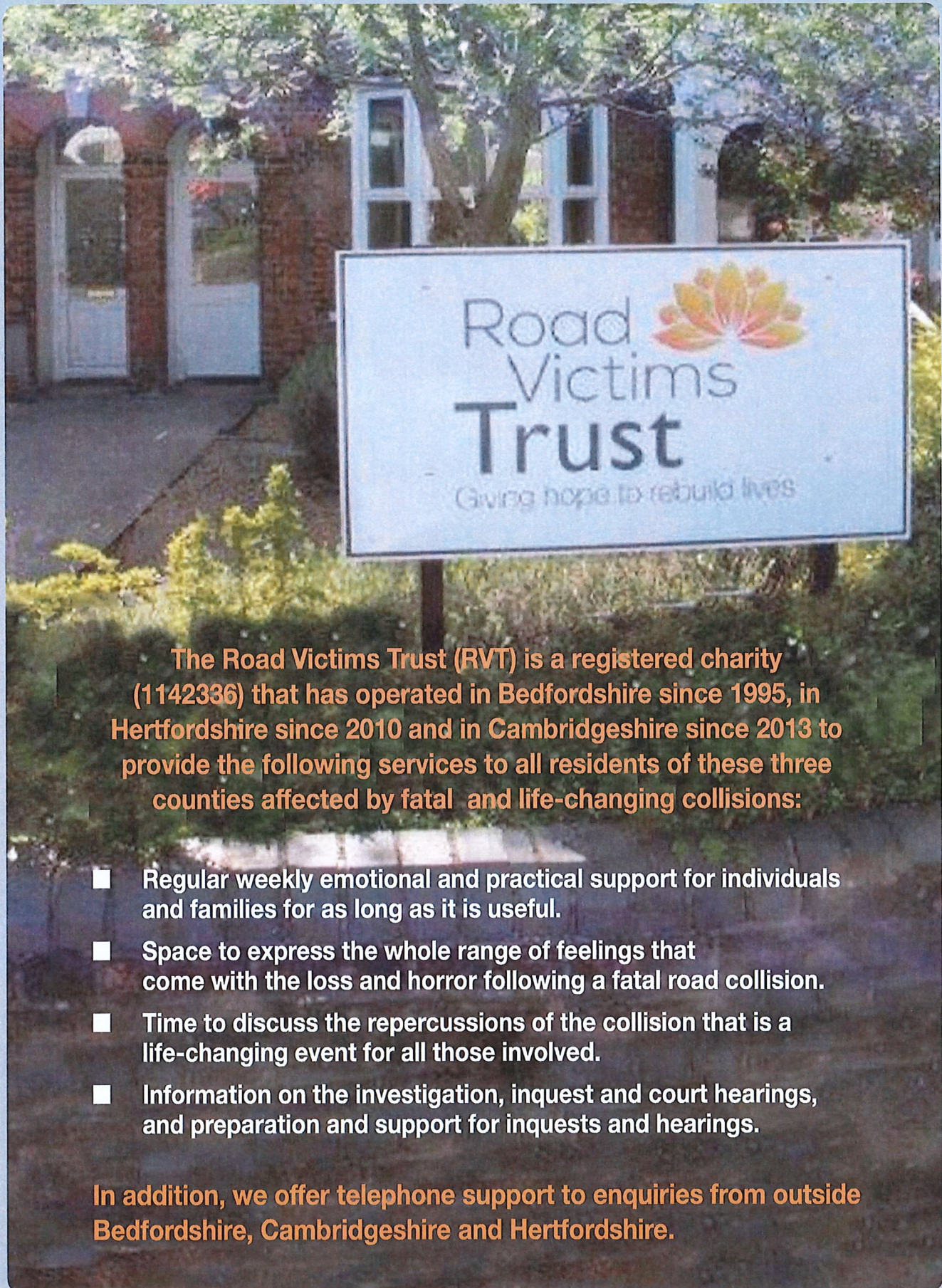
Additionally a team of Patrons, Ambassadors and Trustees bring a wealth of experience and influence to our strategic direction and delivery.

## ROAD VICTIMS TRUST VALUES



**The Road Victims Trust (RVT) is a registered charity (1142336) that has operated in Bedfordshire since 1995, in Hertfordshire since 2010 and in Cambridgeshire since 2013 to provide the following services to all residents of these three counties affected by fatal and life-changing collisions:**

- Regular weekly emotional and practical support for individuals and families for as long as it is useful.
- Space to express the whole range of feelings that come with the loss and horror following a fatal road collision.
- Time to discuss the repercussions of the collision that is a life-changing event for all those involved.
- Information on the investigation, inquest and court hearings, and preparation and support for inquests and hearings.

**In addition, we offer telephone support to enquiries from outside Bedfordshire, Cambridgeshire and Hertfordshire.**

# SERVICE TEAM REPORT

01/04/2020 – 31/03/2021

The Road Victims Trust (RVT) provides free counselling sessions for as long as this is useful. We also offer practical support through the legal and administrative processes following serious road collisions.

Since mid-March 2020, when restrictions on meeting in person came in due to Covid-19, RVT changed the way in which we support our Clients, moving immediately to telephone sessions and later, following further training, to offering the option of online counselling support sessions and we will continue to work in this way until we can safely return to in-person working.



Whilst restrictions from March meant that there was far less traffic on the roads for a period, it is of note that the number of fatal and Life- Changing collisions referred remained close to the levels that we regrettably see each year.

In February 2021, ten new Counselling Volunteers began our 50hour specialist training course which was delivered live on zoom and as a result eight further Counsellors have joined our team. We also developed our capacity to work with Children and Young People (CYP) by providing a number of our Counsellors with high quality CYP training.

In addition to our core service, during 2020, we also supported the development of the online Learn2Live Programme alongside the Herts Road Safety Partnership by being part of their video presentation; we also provided bereavement and trauma training for a counselling training centre in Hertfordshire.

It has been a challenging year, however, the service we provide, whilst different from pre-pandemic times, has remained of high quality and this is due to the exceptional commitment and professionalism of both the staff team and our valued Counsellors who offer their services on a voluntary basis.

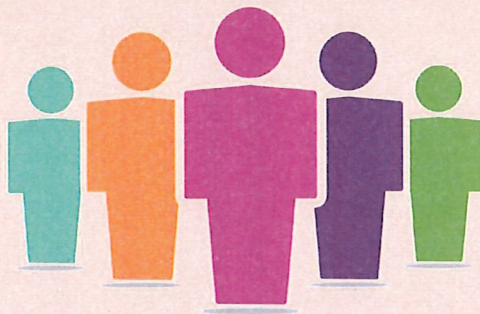


## During the reporting period from April 2020 to March 2021

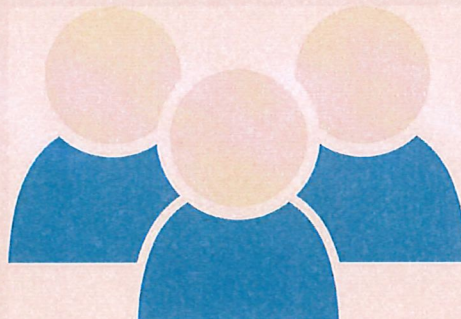
Received 137 referrals relating to fatal and life-changing collisions - 80% of which were from the Police in Bedfordshire, Cambridgeshire and Hertfordshire.



Provided long-term support to 249 individuals by way of a one to one counselling service.



Provided 1,408 hours of specialist counselling sessions.



Provided 3,200 of dedicated staff time ensuring the needs of clients are met.

Maintained, trained and retained a cohort of 55 highly trained and qualified Counsellors.

## RVT and the Police – A Partnership Approach to Supporting People

Chief Superintendent David Boyle BA Mst (Cantab) is Head of Specialist Operations for the Joint Protective Services across the three counties.

Speaking about the unique partnership between Police and the RVT, David says “It remains our absolute privilege to continue to work with the Road Victims Trust. The impact of the death of a loved-one in a road traffic collision is difficult to comprehend, and the role of the RVT in supporting people through some of the most difficult times of their lives is truly humbling.



The care provided by RVT Counsellors assists people to recover from trauma, grief and loss and we are proud to work closely with such extraordinary people. Having recently reviewed and signed off our service-level agreement again, we have reaffirmed the ongoing commitment of Bedfordshire, Cambridgeshire and Hertfordshire Joint Protective Services to work in partnership with this remarkable charity”.

# Working Together to Reduce Casualties on the Road



The Road Victims Trust are represented at the three Strategic Road Safety Partnerships across Bedfordshire, Cambridgeshire and Hertfordshire. These partnerships all strive to reduce the amount of casualties on the roads of the three counties and we are able to bring our experience and expertise specifically to look at the Post Collision response.

Simon Brown (pictured) chairs Hertfordshire's Road Safety Partnership and works for Hertfordshire County Council Highways. He oversees a number of teams including driver and cycle training, safety cameras, road safety education, crossing patrols and travel planning.



Simon explains *'Hertfordshire's Strategic Road Safety Partnership has the following vision:*

*To support stakeholders in delivering co-ordinated and targeted activity through a holistic mix of engineering, education, engagement and enforcement to reduce road casualties, antisocial road use, community concerns and costs to society. The Road Victims Trust are integral to the delivery of that vision, not just through their traditional 'post collision response' role supporting people affected by the trauma of serious and fatal collisions, but also as part of wider preventative initiatives.*

Deputy Chief Constable Trevor Rodenhurst is the Chair of the Bedfordshire Strategic Road Safety Partnership. Speaking about the partnership arrangements Trevor says:

*"The Road Safety Partnership and Roads Victims Trust continue to be proud to work collaboratively with the Police Officers and Police Staff across Bedfordshire, Cambridgeshire and Hertfordshire. The unique working arrangement and service-level agreements mean that RVT are informed of every fatal collision and numerous other life-changing injury collisions that occur on the roads of Bedfordshire and beyond. 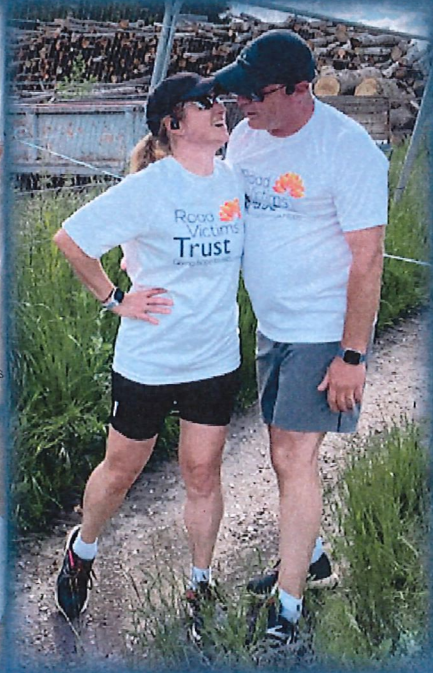
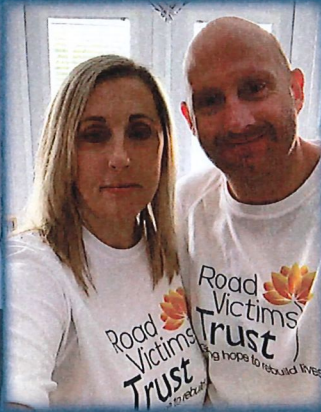

# Clifton Ibbett OBE 1937-2021

## The Founding Trustee of the Road Victims Trust

Clifton Ibbett, who died on May 6th aged 83, was a former High Sheriff of Bedfordshire (2004), a successful businessman and a modest philanthropist who backed numerous good causes all over the county of Bedfordshire. Clifton was a founder of the Road Victims Trust and remained a fully active and engaged Trustee right up until the end. Together with his good friend, and present Treasurer, Bob Panton, the solid foundations of the RVT were put into place and built upon. The early days of the RVT were difficult, as regular funding streams were difficult to establish, and it was Clifton's immense spirit and generosity that kept things afloat.

Some years ago, Clifton spoke about the formation of the Trust and said "I was involved right from the beginning when, a couple of years after my two daughters had been killed in a fatal road collision on December 23rd 1982, I was at a Black Tie function in the town. I happened to be sitting next to and opposite the then Director of Victim Support and the then Deputy Chief Constable – and the conversation somehow got around to how did I cope with the loss of my two daughters? I explained that I and my then wife had tremendous support from friends and relations.

I count myself very fortunate to have had very supportive parents, a reasonably strong Christian faith, many friends connected with the church, many friends and business colleagues and not in any way to belittle them many Just Friends. It was an amalgam of all these people with their many and different backgrounds and life experiences which helped us through the first 7-8 months up to the time when my wife left me in July 1983.

After my wife left, my son John – then 21 – and I looked after each other. On one very cold February evening in 1984 we both arrived at the back door together. John had had a particularly bad day at work, and he broke down and said "you and mum had a lot of support when the girls had their collision, but nobody realised I had lost my sisters."

As a consequence of recounting this in the conversation it was decided something formal should be set up and we arranged a further meeting – which for a multitude of reasons did not take place for over a year. Eventually it was decided we would start something under the auspices of Victims Support and with the active involvement of the police. A meeting was held to which the great and the good of the county were invited, along with interested family members of recently bereaved persons.

The first office location was in a portacabin in the Bedford Road police station. It then moved to the Victim Support premises in Kempston, and we received great support and encouragement from the Director. It soon became apparent that we did not fit with Victim Support national procedures and in spite of the best efforts of the team we could not get a sustainable working arrangement. Thus the Road Victims Trust was born and the rest from then on has been a real success story.
