9.1 GREAT CAMBOURNE CRICKET PAVILION

Pergola

The Town has been working with Cambourne Cricket Club (CCC) on the installation of the pergola to the front of the pavilion where the decking is.

The Town Clerk met with a representative of the CCC and the proposed installer of the pergola and agreed a suitable installation that does not have a negative impact on the building. (copy of agreed drawings attached).

The Town Clerk has been in Discussion with the Planning Department at South Cambs and it may be considered as permitted development.

9.2 CAMBOURNE SOUL

The Town Council has received the following request.

Dear Councillor O'Dwyer and John,

Please can I introduce myself? My name is Clare and I am the Ministry Team Leader for Children and Young People at Cambourne Church. I am relatively new to the role having been in post since June.

Part of my role is to facilitate the children's and youth work that runs alongside our Sunday morning services. With the main service taking place in the church hall, we run a créche in the foyer and a children's group in the annexe. Our young people and youth leaders head over to Cambourne Soul for their session — we feel privileged to use a building that is purpose built for youth work and it is a space our young people feel comfortable in, particularly given that some attend other youth work activities in the same building.

On Friday, a message was passed onto me that we are no longer allowed to use the Soul building on Sunday mornings. This message was shared with me via our Church Administrators and didn't offer any explanation.

I appreciate that I do not fully know the history of our arrangement to hire this space and so I am willing to work with you to clarify that. What I do know, is that I have a youth group who need a place to meet on a Sunday morning and that consistency is important. It would be such a shame to lose access to the building and the connection with wider Cambourne youth activities.

For further context for future use:

On Sunday mornings, our children, young people and families come to church for our 11am service. We start all together in the church hall then we split into age-based groups. The adults stay in the church hall, we run a créche in the foyer and a children's group in the annexe. Our young people and youth leaders head over to Cambourne Soul for their session.

When at the Soul Building, we make hot chocolates, play games and facilitate discussions around the themes of faith, identity and purpose. Each Sunday the group will consist of around 10 young people of secondary school age (11 to 18 year olds) and 2 DBS-checked and safeguarding-trained youth leaders. Participation in this group is voluntary; we treat young people with respect –valuing each young person and acting in a way that does not exploit or negatively discriminate; and we seek to respect and promote young people's rights to make their own decisions and choices.

The young people stay in our church building for the whole service on the first Sunday of each month, so the next date we're hoping to use the Soul Building is Sunday 14th January. I can send you dates for the next term if that would be helpful.
